Industry advocacy has always been a huge focus of the Association, but this past year found the Print & Graphic Communications Association very hard at work on issues critical to the industry's future success.

**Without the support of our membership dues, the Association would not have the resources to act on these issues as they arise.**

#### Recent Advocacy Efforts

PGCA mobilized grassroots campaigns through our Legislative Action Center, hired trusted lobbyists, contacted legislators directly, arranged meetings between members and legislators and other elected officials, partnered with other businesses and organizations, launched extensive social media campaigns and distributed fact sheets and white papers to legislators.

#### Recent Advocacy Topics:

➤ **New York State: Carbon Black** – Without our focus on this critical issue, it is doubtful that the proposed ban, *which would have essentially destroyed the packaging and label business in NYS*, would have been removed from the overall bill.

➤ **New Jersey: EPR and Carbon Black** – PGCA's efforts, in collaboration with other business associations, succeeded in removing the ban on Carbon Black, when used for print, from the proposed Extended Producer Responsibility (EPR) Bill.

➤ **Virginia: Sales Tax** – Virginia's sales tax exemption provides parity between Virginia advertising agencies and out of state agencies when producing printed material qualifying for the exemption. PGCA has been working to have the exemption extended for another three years.
